Proponents may only register and submit one Project Bid per Project. Proponents must not submit a Duplicative Bid. A Bid will be considered to be a Duplicative Bid if it is in respect of essentially the same Project as another Bid from the same Proponent or its Associates, and only has changes to the configuration or design (such as storage duration or nameplate capacity).

If a Proponent submits Project Bids that are considered by AEMO to be Duplicative Bids, AEMO will accept the compliant Bid that was lodged last. Previously submitted Duplicative Bids will not be accepted and will not be assessed. If Proponents wish to change their Bid, they must notify AEMO via the Online Portal that they wish to withdraw their existing Bid, and then register a replacement Bid before the Registration Closing Date and Time, and submit a replacement Project Bid prior to the Project Bid Closing Date and Time.


